About this dataset: This dataset compiles information about sexual assault prosecutions (charges of rape and of assault and battery with intent to rape) by the colonial and state governments in New York City and County (Manhattan, in this period) from surviving legal records. It does not include information about sexual assaults in other jurisdictions (such as British courts martial during the Revolutionary War or prosecutions in other counties); nor does it include references to sexual assaults in civil actions or in criminal cases in which the charges did not include rape or attempted rape.
